This contract constitutes an agreement for photographic services. It is also understood that any and all negatives and / or digital images remain the sole property of Ellen Le Roy Photography and they may be used for advertising, display, or any purpose thought appropriate by Ellen Le Roy Photography.

The photographer for this event will be Ellen Le Roy. In the event of illness, family emergency, or other event out of the control of Ellen Le Roy another photographer will appointed. In the event that such a substitution is required, Ellen Le Roy warrants that the photographer appointed to the job shall be a competent professional and will be made available at no extra charge.

If Ellen Le Roy cannot perform the actions of this contract due to fire, natural disaster, terrorism, war, theft, illness or any other act beyond the control of said parties, the photographer shall return the retainer to the client but shall have no further liability with respect to the contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the photographer. Although all care will be taken with the negatives and digital media, the client agrees that the photographer limits any liability for loss, damage, or failure to deliver pictures, for any reason, to no more than the return of all payments made.

The negatives digital files are kept by the photographer for 1 year. It is the client's responsibility to contact the photographer for purchase of their negatives or digital files.

Ellen Le Roy and her assistant photographer shall be the only hired professionals to photograph the wedding event. Amateur photographers may take photos during the event as long as they do not interfere with or get in the way of the contracted photographers. If interference happens the contracted photographer will notify a designated family representative on site to handle the situation.

Upon signature of this contract, Ellen Le Roy Photography reserves the time and date agreed upon, and will not make other reservations for these times and dates. For this reason, all payments are nonrefundable and nontransferable, even if the date is changed, postponed or the wedding is canceled for any reason.

A non-refundable retainer is due at signing of this contract. The retainer is \$500. The retainer will be applied to the package total. Another payment of _____ is due 1 month prior to the wedding date. No part of any order will be delivered until balance is paid in full. All prices are subject to North Carolina sales tax. The studio is not bound until the non-refundable retainer is paid and accepted and this contract is signed.
